### PERSONAL DATA PROCESSING POLICY

(Art. 13 of Regulation (EU) no. 679 of 27 April 2016)

This document complements the general privacy policy for the web services by Regola S.r.l. (<https://privacy.regola.it>).

## 1. WHO PROCESSES YOUR PERSONAL DATA

The Data Controller is Regola S.r.l. with headquarters in Turin (TO), Corso Turati, 15 / H - VAT number 06860880019

## 2. HOW YOU CAN CONTACT THE PERSONAL DATA PROTECTION OFFICER

## 3. TYPE AND ORIGIN OF PERSONAL DATA USED

We collect, record and use the personal and identification data (surname, name, e-mail address and password) that you provides us with during the registration phase as well as further contact details (telephone number and social media account) that you may decide to provide to personalise your communication channels.

When you decide to authenticate yourself using your social account or to select it as your additional communications channel, we will collect the information associated with that account, which normally includes the following data: id, name, image, gender and localisation language and, in some cases, your "Friends" on Facebook. If you have made further data publicly available, they will also be available.

Computer systems and software procedures used for the functioning of the Portal acquire, during their normal operation, some personal data whose transmission is implicit in the use of Internet communication protocols. This category of data includes the IP addresses or domain names of the computers and terminals used by users, the URI/URL (Uniform Resource Identifier/Locator) addresses of the requested resources, the time of the request, the method used to submit the request to the server, the size of the file obtained in response, the numerical code that indicates the status of the response given by the server (successful, error, etc.), other parameters related to the user's operating system and computer environment. This data, necessary to visit the portal and use the service, is also processed for the purpose of checking its correct functioning and of guaranteeing its security.



## 4. DISCIPLINE APPLICABLE TO THE PROCESSING OF YOUR DATA

The data will be processed pursuant to EU Regulation 2016/679 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, known as the GDPR (General Data Protection Regulation) and the Legislative Decree 196/03.

## 5. HAVE YOU ALREADY RECEIVED ALERT MESSAGES BEFORE YOUR REGISTRATION TO THE SERVICE?

In some cases, you may have received notifications from the alert system because your personal contact data may have been entered directly by Organisations (your city, civil protection, ...) on the Alert System platform. In this case, for more information regarding the processing of personal data for purposes related to civil protection, you can visit the institutional website of the Organisation from which you received the message.

## 6. WHY WE USE YOUR PERSONAL DATA

We will use your personal data to meet your request for the provision of the Service (you can view the Terms of Service on the website: <https://privacy.regola.it>). The processing of data is therefore necessary for the execution of the Contract.

## 7. FURTHER INFORMATION IN CASE YOU USE THE SERVICE THROUGH THE 'ALLERTE ITALIA' SKILL

'Allerte Italia' is a free Alexa skill (available only on Amazon's Italian marketplace) linked to the nowtice alert service that you can activate on your Amazon account.

If you decide to use the 'Allerte Italia' skill, you will have the opportunity to receive notifications from the Organizations registered on the service on your Alexa devices and listen to the communications that will be published on this portal.

## 8. TO WHOM WE COMMUNICATE YOUR DATA

Your data will be provided to the Organisations using the Service to which you decide to register in order to receive communications and alerts.

We inform you that these Organizations will process the data as independent Data Controllers.

## 9. TRANSFER OF YOUR PERSONAL DATA TO THIRD COUNTRIES

The service is based on private and public Cloud systems with data centres mainly located within the European economic area. However, due to the characteristics of the cloud services, your personal data may be transferred to countries located outside the European Union. In such cases, we will ensure that appropriate safeguards are guaranteed in accordance with the provisions of Regulation (EU) 27 April 2016, no. 679 (articles 44-50).

## 10. HOW LONG WE WILL KEEP YOUR DATA

Your personal data will be kept for as long as you remain registered with the Service.



## 11. YOUR RIGHTS REGARDING PROCESSING


We inform you that you have the right to: obtain access to your personal data; their updating, integration, correction or erasure; the restriction of processing and the right to object to it; request the blocking of data processed in violation of the law, including those which need not be kept for the purposes of processing.

You can exercise many of these rights directly from the administration panel of your account.

However, to exercise your rights you can contact us directly or the Data Protection Officer through the contact details provided in points 1 and 2 of this information document.
